Wow! I can't believe how the years have flown by! As I look back on the past four years that I've served as AEPNA President, I see a lot of accomplishments that the association spearheaded, organized, funded or supported.

We raised \$50,000 for a park renovation. We applied for grants, got grants, and matched grant money for special projects. We served beer. We served pancakes. We planted trees. We watered trees. We planted more trees. We hosted potlucks, soup-fests, chili-fests and celebrations big and small. We organized fundraisers. We organized regular park clean ups, dumpster days and garage sales. We got a walkway to bridge the neighborhood and the University village. We hosted garden tours, arena tours, tours of green homes and assisted living homes. We did all this and a whole lot more.

Any one of the items or events may seem simple from the outside, but I know the effort that went into them behind the scenes was sometimes heroic and often thankless. Something as simple as putting a break in the fence between the University and Woolworth Avenue took two years...

It has been a real privilege to serve the neighborhood through the association. The officers and volunteers are some of the finest people I've ever met, and I'm glad to know that they're my neighbors. I don't have the space to thank everyone here, but I have to give special recognition to some who have served selflessly for a long time.

Secretary Tim Potter keeps all our notes and minutes. Treasurer Eileen Slane, keeps all our books and was instrumental in keeping the park renovation and celebration on track. Membership Director Scott Swanson keeps the roster and handles email communication with members. Communications Director Therese McGrath keeps the peace on Facebook. Social Director Lois Ourada keeps us well fed at the business meetings. Newsletter Editor Colleen Ciciulla keeps me on message. And last, but not least, my wife Marilyn keeps me sane and humble.

AEPNA - What's In It For Me?

When told that the newsletter might not be printed and mailed any longer, a member asked,

"So please explain to me what my membership has paid for exactly?"

Thank you for asking! Let's start with your \$10 annual household membership dues:

If you pay by cash or check, AEPNA gets \$10 or **\$0.83 per month**. If you pay \$25 via PayPal for a 3-year membership, you get a discount, PayPal gets a fee, and AEPNA gets **\$0.67 per month**.

So, your paid membership gives AEPNA between \$0.67 and \$0.83 a month to cover operating expenses and provide the following kinds of services:

- Annual fee for hosting website (maintained by AEPNA volunteers)
- Annual membership dues to umbrella associations
- Annual Garage Sale advertising (all other garage sale related activities are donated by AEPNA members)
- Donation to St. Matthews for their generously allowing us to use their facilities (meeting space & kitchen) for our bi-monthly meetings
- Facebook page (AEPNA volunteers provide administration of the page at no charge to AEPNA)
- Host neighborhood garden walks and other fundraisers to support AEPNA
- Matching funds for grants to make neighborhood improvements, using volunteer hours for in-kind funds where possible (members donate their time to research, write, manage and following up on grants)
- Paper products, coffee, tea, etc. for the 6 membership meetings (most food is donated by members)
- Park Pavilion rental and main dish for the annual picnic (side dishes are donated by members)
- Printing costs for notices distributed throughout the neighborhood to announce various AEPNA activities and/or solicit members
- Printing and mailing costs for the newsletter (members donate time to write, research and produce)
- Provide volunteers to facilitate annual events like 'Clean-up/Dumpster Day' for the neighborhood
- Schroeder/Vogel Park maintenance (dog waste bags and miscellaneous items most of which are donated by members)

As you can see, AEPNA functions mostly on the efforts of dedicated volunteers who selflessly provide their time to make our neighborhood a wonderful place to live! Please join us and see how investing \$0.83 per month can make you rich!

Newsletter Update

The cost of printing and mailing the newsletter has been subsidized over the years in various ways. We believe that the newsletter provides a valuable service to the community and we plan to continue producing it, but we need some help.

Thanks to Tom Hansen and Denie Nesvan who came to the Dec. 17th meeting to address how to best continue this service. The cost of printing and mailing would be about \$.075 per piece, which consumes the bulk of the monthly dues (see above). Advertisers or sponsors would defray the cost, but volunteers would have to find those advertisers and handle the bulk mailing.

The officers agreed to a short-term solution. For January and February, we will email the newsletter and

Midtown Monitor to all members who provided an email. Those without emails will get a hard copy, hand-delivered by one of the officers, who will ask for the member's email. We'll reassess in February and decide how to proceed for the long term.

This is a great time to shake up the newsletter content and make it more valuable to members and more appealing to potential advertisers or sponsors. With a neighborhood as vibrant and rich in history as ours, each issue should have content covering different aspects of the area, including business, culture, history, architecture, gardens, and human interest. Any one of those sections could be your "beat" if you're willing to volunteer your time and your talent for your neighborhood. Contact Colleen Ciciulla to contribute.

60th & Woolworth – Two Burning Questions

Trina Westman (neighbor and architect in the Urban Design and Historic Preservation Section of the City Planning Department) has gotten some calls about the available space at 60th & Woolworth. Her research showed that the building was built in 1924, and has always been a commercial site. It's had multiple lives as a drug store (Crestwood Drug), grocery store (Shaver's Food Mart), a convenience store and gas station, and most recently a golf specialty shop.

Trina's research turned up photos of the inside of the grocery store and a 1977 Omaha World Herald article about a fire that burned the building to the ground.
